



“One Health – challenges to implementation in the Community of Portuguese-speaking Countries”

Spread across several continents, the countries of the Community of Portuguese-speaking Countries (CPLP) share a common language and face increasingly complex global challenges, from climate change and biodiversity loss to emerging diseases, food safety/security and social inequalities. In this context, the **One Health** approach offers a unique opportunity to promote integrated solutions that recognise the interdependence between human, animal, plant and environmental health. With one language and one shared vision of collaboration, Portuguese-speaking countries have the potential to strengthen cooperation, share experiences and accelerate responses to challenges that transcend borders. This workshop, dedicated to future generations of One Health professionals and leaders, aims to create a space for reflection and dialogue on some of these challenges, exploring how the effective implementation of the One Health approach can contribute to more resilient, sustainable societies that are better prepared for the future.
